GEMKHANA 2019 OUTDOOR TRADERS CONTRACT **Hawkesbury Showground, 28th & 29th September**

The Gem & Lapidary Council of NSW Inc (hereafter "Council") and _____ (hereafter "Trader") hereby agree to the following:

The Trader will rent outdoor trading space at the cost of \$50 for each 3 square metre site.

If additional meters are wanted for the site the cost will be \$20 per meter

If the site is wanted for a single day the cost is \$20 for 3 sq meters and \$5.00 for each additional meter

If camping on-site your camping fee will be collected and paid directly to H.D.A.S.G.

Setting up will be allowed on Friday 26th September. The show will open 9am. Saturday 27th September.

The Council takes no responsibility for any damages or incidents that occur at the stall.

The Council is permitted to take photographs of the booths and Traders and use these photographs for advertising and promotional purposes.

The Trader will not sublet or rent out any part of his/her assigned space.

The Trader is required to produce proof of current public risk insurance to the value of \$20,000,000 with their payment.

The Trader will be responsible for any damage or injury to persons or property which may be occasioned by or caused by or arise out of the use of any machinery, implement or apparatus whatsoever used in conjunction with the stall and hereby indemnifies the Council accordingly.

The Trader will provide all equipment necessary to run the stall.

The Trader agrees to trade ONLY in the hours the show is open, and in areas allotted by the organisers.

The Trader will sell only items that are authentic lapidary or lapidary-allied, and such items are clearly labelled and marked with the retail price.

The Trader will trade in a respectful manner at all times and follow instruction from the organisers.

The style and location of advertising signs shall enhance the overall character of the show and shall not infringe on any other aspect of the show.

In the event of termination of this contract, the Trader will notify the Council in writing.

Consideration will be given to a refund at the meeting of the Delegates of the Gem and Lapidary Council of NSW following receipt of the notification. The Trader agrees to the above conditions, realising that failure to do so will mean his/her exclusion from the exhibition.
